### The National Land Coalition Uganda

The NLC Uganda platform was launched in 2019 and started implementing activities in January 2021. The platform comprises of over 40 members stakeholders ranging from several international organizations, development partners, academia, cultural institutions, media and researchers, Non-Government organizations, Community Based Organizations, Grassroots organizations/movements, working in collaboration with Government Ministries, Departments and Agencies (both at local and central government levels) whose missions and visions are in line with the ten commitments of the International Land Coalition. The different organizations bring in different expertise in the core land governance thematic issues of the NLC as well as other critical technical skills necessary for effective advocacy including capacity development, research, advocacy, media, resource mobilization, movement building etc.

A Uganda where everyone enjoys absolute land tenure security irrespective of their status

#### **NLC Goal**

Promote people centred land governance through policy and practice change in adherence to Uganda's Vision 2040

## **NLC Mission statement**

To strengthen coordination of state and non-state actors at national and local levels to collectively advocate, formulate, review and implement people centred land policies in Uganda

## **Strategic Objectives**

- 1. To build a competent coalition of non-state actors working collaboratively to address land governance challenges in Uganda.
- 2. To influence the formulation and implementation of people centred and gender-responsive land laws and policies in Uganda.
- 3. To strengthen capacity of land actors to effectively advocate for people centred land governance
- 4. To collect, generate and manage land governance data to facilitate evidence-based advocacy interventions on land.
- 5. To mobilize resources for implementation of the strategy priority areas

#### **NLC Thematic Areas**

The NLC in Uganda is implemented through thematic Groups, these were constituted to steer the Country Strategy. These include:

1. Tenure systems and land inequality,

- 3. Natural Resource Management and Climate change,
- 4. Food systems in Uganda,
- 5. Land Rights defenders,
- 6. Land and Investment,
- 7. Women, Youth and other Vulnerable Groups, and
- 8. Urbanization and Housing.

NLC Uganda is a loose coalition with open membership to interested stakeholders whose missions and visions align to that of the Coalition. The coalition is governed by an eleven (11) member steering committee. The current members include; 1. Land Equity Movement Uganda (LEMU) — the host organization, 2. Saferwold Uganda, 8. Eastern and Southern Africa Small Scale Farmers Forum Uganda, 9. African Centre for Media Excellence (ACME). 10. Witness Radio Uganda and 11. Oxfam Uganda
